3. Annual Proceedings

M.E.G.H.P.,

The Proceedings of the 2024 Annual Grand Convocation have been accessible on the Grand Chapter website since November 2024. Given that the 2024 Proceedings have been available for inspection and review, and will remain so, I hereby propose that they be accepted as posted, pending further corrections should any issues arise found.

4. Report of the Grand Secretary

R.E. Comp. William C. Eppig, G. Sec

990N: A yellow banner on the gateway page of yorkritemaryland.org links to the most efficient route to the I.R.S. 990N submission page. Although the I.R.S. requires this form to be completed every two years, the Grand Chapter needs it completed annually. Yearly filing helps prevent a failure to report, especially if a change in secretaries occurs. If this happens, you may lose your E.I.N. #.

General Grand Chapter Annual Report: The General Grand Chapter Annual Report and accompanying fees were filed in November 2024. With the new MMS system, I am confident that this was the most accurate filing in years. We reported 896 members for the year 2024, of whom 7 were General Grand Chapter Perpetual Life Memberships. This left us with assessments to pay to the General Grand Chapter for 889 members.

MMS: The new MMS has been online for almost a year. I know there are still some growing pains with a few of our secretaries, but overall, I feel that the system has been well-received. As stated above, we have the most accurate membership accounting in years. We also have access to several useful reports helpful to our chapters and the Grand Chapter.

With the new MMS, we could use a dues card processing vendor. The Grand Encampment, Scottish Rite, and many other organizations use this vendor. I can assure you that the dues card process was much easier for me as Grand Secretary, and I thank the Grand Chapter for allowing the use of this vendor and Masonic member solutions.

Royal Arch Magazine: In recent years, I have undertaken the task of rectifying the mailing list utilized by the General Grand Chapter to distribute the Royal Arch Magazine. This process was challenging due to the outdated Access database system, which contained numerous inconsistencies. However, with the implementation of the new Membership Management System (MMS), which is the most up-to-date and accurate system available, I successfully provided the current membership names and addresses to replace the previous data.

The quarterly bill in 2021 averaged \$715.00, totaling \$2,860 for the year. Last year, the average quarterly cost was \$643.00, amounting to \$2,572 for the year. The past spring issue, using correct data, incurred a cost of \$545.00, resulting in an annual expenditure of \$2,180. Consequently, this has yielded approximately \$680 in annual savings since 2021.

The report of the Grand Treasurer is that the Grand Chapter is in good financial condition. The Treasurer's Final Report for 2024 is attached. Although the report shows the year being short \$5,756 in income, we spent \$8,091 less than budgeted and stayed in the black.

The Semi-Annual Treasurers Report for 2025, as of May 5, 2025, is attached, along with the 2025 Interim Report for the Trustees Reserve Fund. The Reserve Fund report shows the status of the account as of March 31, 2025. The value of the account and its investments as of that date was \$596,362.78, that's a 1% decrease since November 1st.

Also attached, as reviewed by the Accounts and Finance committee, is the proposed budget for 2026

They require a team and need to be performed from memory. Both programs are available on the website and can be obtained from the Grand Secretary and Grand Lecturer.

RE Comp. Eppig reported that he reviewed the available records and added the awards the companions earned to their profiles in the MMS. He also emphasized that members need to register for MMS usage so they can update their personal information and notify us of any mistakes if they received awards from the Grand Chapter.

He also suggested that the Award Committee review all the awards presented by the Grand Chapter and codify them along with their requirements. This should be added as an appendix to the Constitution.
